1.) Justin Fairbanks gave an update on the ~~Word~~ **Rural** Business Development Grant. The grant was not approved, but we were encouraged to apply again.


2.) Rowan Bunce shared that the Conservation District was awarded a \$21,000 Rural Ag grant which will be going to the Chatham community gardens.
