## **Rock River Township Allocated Operating Millage Proposal**

Shall the voted allocated township millage rate of 1 mill (\$1.00 per \$1,000 of taxable value), reduced to .7838 (\$0.7838 per \$1,000 of taxable value) by the required millage rollbacks, be increased by 0.2162 (\$0.2162 per \$1,000 of taxable value) to the original allocated rate to recover that millage reduction and be levied by Rock River Township for 6 years, 2020 through 2025 inclusive, for general operating purposes, which 0.2162 mills increase will raise an estimated \$8,664 the first year the millage is levied?
