2.) Resolution for Fire Truck Payment and Signature:

WHEREAS, the residents of Rock River Township at the August Primary voted and passed a millage to allow for the purchase of a new fire truck for fire protection within the Township of Rock River.

WHEREAS, PA 99 of 1933 (Purchase of Lands and Property for Public Purposes) allows the township to enter into an installment loan agreement for the purpose of purchasing a fire truck.

NOW, THEREFORE BE IT RESOLVED, that the Township Board of Rock River will enter into an installment loan agreement with Peoples State Bank at 6.25% to borrow the money necessary to purchase a Rosenbauer Pumper for \$209,650. The Township Board will use anticipated revenue from the fire truck millage so that this installment loan is repaid within the eight year life span of the fire truck millage. The Board also authorizes the Clerk to sign the necessary loan documents.
