<u>UNFINISHED BUSINESS:</u> 1.) <u>Diversity, Equity & Inclusion Statement:</u> tabled until we hear from our attorney. Supervisor addressed questions/comments from last meeting. Trustees stated that the DEI wording is not set in stone, the board is willing to amend the language.

5.) Clerk, Treasurer, Supervisor Raises: Trevor has done extensive research on how much Township Officials in our County are compensated. He found our Township is lower than all but one other township. He proposed that the Clerk, Treasurer and Supervisor each receive \$600.00 per month, which is a \$100.00 raise for the Clerk and Treasurer and a \$150.00 raise for the Supervisor. Board discussed. These raises will not take effect until April 1, 2023, which is the beginning of the new fiscal year for the township.
